Each mechanized vehicle driver who has a driver's permit, yet can't show it during a strike, will be rebuffed with detainment for a limit of multi month or a fine of a limit of IDR 250,000 (Article 288 section 2); 3. Each driver of a mechanized vehicle who doesn't have a vehicle enlistment number showed will be rebuffed with detainment for a limit of 2 months or a fine of a limit of IDR 500,000 (Article 282); 4. Each motorbike rider who can't be as expected outfitted with a vehicle, for example, mirrors, headlights, brake lights, horn, speed measure, and suppressor will be rebuffed with detainment for a limit of multi month or a fine of a limit of IDR 250,000 (Article 285 section 1)[12].
